

## **Data privacy statement**

### **1. Data privacy - overview**

The following provides a simple overview of what happens with your personal data when you visit our website. Personal data is any data which can be used to identify you personally. Please refer to our data privacy statement below this text for detailed information on the topic of data privacy.

#### **Data collection on our website**

##### **Who is responsible for data collection on this website?**

Data processing on this website is provided by the website operator. Please obtain their contact details from the legal information of this website.

##### **How is your data collected?**

On the one hand, your data will be collected by you providing us with this information. This can be, for example, data that you send us by e-mail.

Other data is automatically collected through respective IT systems when you visit the website. These are primarily technical data (e.g., Internet browser, operating system or time of page visit). This data is automatically collected when you access our website.

**For which purposes do we use your data?**

Part of the data is collected to ensure error-free provision of the website. Other data can be used to analyse your user behaviour.

**Which rights do you have regarding your data?**

At any time, you have the right to obtain information about the origin, recipient and purpose of your stored personal data free of charge. You also have a right request correction, blocking or erasure of these data. You also have the right of appeal to the competent supervisory authority.

**2. General information and mandatory information****Data privacy**

The operators of this website take the protection of your personal data very seriously. We treat your personal data confidentially and in accordance with the legal data protection regulations and this privacy statement.

**Revocation of your consent to data processing**

## **Right to data portability**

We did not appoint a data protection officer in our company because this is not required by law due to the size of the company.

#### **4. Data collection on our website**

##### **Cookies**

The Internet pages partly use so-called cookies. Cookies do not damage your computer and do not contain viruses. Cookies are used to make our website more user-friendly, more effective and safer. Cookies are small text files that are stored on your computer and by your browser.

Most of the cookies we use are so-called "session cookies". They are deleted automatically at the end of your visit. Other cookies remain stored on your device until you delete them. These cookies allow us to recognize your browser upon your next visit.

You can adjust your browser settings such that you are informed about the use of cookies and allow cookies only on a case-by-case basis, accept cookies for certain cases or exclude this generally as well as automatically delete cookies when you close the browser. Disabling cookies may restrict the functionality of this website.

##### **Server log files**

The provider of the websites automatically collects and stores information in so-called server log files which your browser automatically transmits to us. These are:

- browser type and browser version
- operating system used

- referrer URL
- host name of the accessing computer
- time of the server request
- IP address

These data are not complied with other data sources.

The basis for data processing is Art. 6 Para. 1 lit. b GDPR which permits the processing of data for the fulfilment of a contract or contractual measures.

### Contact by e-mail

If you contact us by e-mail, we will store your data from this e-mail including your contact information specified there for the purpose of processing your request and for the case of follow-up requests. We do not share this data without your permission.

Processing of the data specified in this e-mail therefore takes place exclusively on the basis of your consent (Art. 6 Para. 1 lit. a GDPR). You can revoke this consent at any time. You can do this by simply sending an informal e-mail to us. The legality of data processing until the revocation remains unaffected by the revocation.

The data you send to us by e-mail remain with us until you request erasure, revoke your consent for the storage or the purpose for the data storage lapses (e.g., after processing your request). Mandatory statutory provisions – in particular retention periods – remain unaffected.
